

6.1.1 Free Usage of Studio for Student's Missed Lessons

- Applicable to all the Courses (Individual and Group)
- Eligibility Criteria
 - Applicable when a student misses a lesson due to personal reasons.
 - The student must remain actively enrolled at the time of studio usage.
 - Entitlement is limited to once per month and must be used within the same month (after the missed lesson) or the following month.
 - Not applicable if the make-up lesson under Article 6.1.2 has been redeemed.
- Students may use available studio for self-practice on weekdays between 12:00 - 17:00 and 20:00 - 20:45.
 - Studio availability is subject to confirmation by Yamaha Music School.
 - The studio is available only at the student's learning branch.
 - Guardian's attendance is required if below 7 years old
 - [Terms of use](#) for rental studio is applied.

6.1.2 Make-up Lesson for Medical Leave

- Applicable to all the **Individual Courses**
- Eligibility Criteria
 - Valid **Medical Certificate (MC)** must be presented.
 - ◇ Neither Traditional Chinese Medicine nor Epidemic-related MCs are accepted unfortunately.
 - Students are entitled to one replacement lesson **every 3 months**.
 - ◇ The interval between the MC dates for replacement eligibility must be at least 90 days.
- Replacement Lesson
 - Duration of the make-up lesson is **50% of the original lesson duration**.
 - ◇ It may be split into 2 times in case the original lesson is extended.
 - ◇ Replacement lesson may be conducted by other teachers (than the original teacher) upon consent of the student.
 - The make-up date and time is subject to the availability of both the teacher and the convenience to the students by the mutual best-effort. The make-up lesson will be scheduled and conducted within 1.5 months (6 weeks) after the MC date, otherwise the entitlement shall be invalid unfortunately.

6.1.3 Feedback Correspondence on Homework

- Applicable to all the **Group Courses**
- Eligibility Criteria
 - Any missed lesson for any reason
- Feedback on Homework (Process Flow)
 - 1) The student shares a **video recording of the performance on the homework piece(s)** to the teacher via Learning Management System (LMS) once per missed lesson.
 - If LMS is not implemented, it may be sent by other manner including e-mail to school.
 - 2) The teacher will give back **one comprehensive feedback** by text or recording for the student.

6.2.1 Free Usage of Studio during Teacher's Leave

- Applicable to all the **Courses (Individual and Group)**
- Eligibility Criteria
 - Any case when the school (teacher) changes the Term Calendar
- Students are entitled to use the original lesson studio limitedly for the purpose of self-practice at the original lesson date and time the lesson of which are canceled due to the reason attributable to the school and/or teacher.
 - There may be several students at the same time in case of Group Courses.
