of Yamaha Music Europe GmbH (hereinafter "Yamaha") to sales contracts for the products "Clavinova CSP-150" and "Clavinova CSP-170" concluded by a commercial agent on behalf of and for the account of Yamaha with an entrepreneur or a consumer (hereinafter "Customer").

§ 2

Subject Matter of the Promotion

Upon purchase and registration of a "Clavinova CSP-150" or "Clavinova CSP-170" (hereinafter "Main Product"), the Customer will receive a 9th generation Apple iPad (hereinafter "Bonus Product") free of charge under the following conditions.

§ 3

Period of the Promotion

To participate in the Promotion, the Customer must purchase the Main Product in the period from February 1, 2023 to March 31, 2023 (offer extended). In case of purchase via e-commerce, the date of sending the legally binding order is decisive. The Promotion is valid only while stocks last. Yamaha is entitled to terminate the period of the Promotion early at any time without notice if the stock is exhausted.

§ 4

Registration Obligation

To receive the Bonus Product, the Customer must register the Main Product by creating a Yamaha Music ID account on Yamaha's website <https://europe.yamaha.com/en/support/promotions/csp-ipad.html?modal=registration>. The Main Product must be registered in the Product Registration section within the Yamaha Music ID account. The Customer must include in the My Data section his/her address to be used as shipping address of the Bonus Product. If the Customer already has a Yamaha Music ID account, he/she must ensure that the Main Product is registered, and the shipping address is included.

The registration, including the indication of the address, must be completed within fourteen (14) days from the date on which the Customer or a third party other than the carrier designated by the Customer has taken possession of the Main Product.

§ 5

Shipment of the Bonus Product

After registration and before the Bonus Product is shipped, the Customer shall receive a confirmation email from Yamaha that he/she has registered for the campaign. After Yamaha verifies that the customer is eligible to receive the Bonus Product, the customer shall receive an email informing him/her of this. In case of any inconsistencies and/or misinformation regarding the personal data provided by the Customer, Yamaha reserves the right to contact the Customer directly for the purpose of the Bonus Product's shipment. The personal data of the Customer stored for the purpose of sending the Bonus Product will be deleted upon 6 months of the end of the Promotion. The Bonus Product will be shipped to the Customer when fourteen (14) days have passed from the day on which the Customer or a third party other than the carrier designated by the Customer has taken possession of the Main Product. If the Customer exercises a right to revoke the purchase agreement for the Main Product, the Customer shall not receive any Bonus Product.

§ 6

Exclusion of Warranty

Yamaha will grant the Bonus Product free of charge under the conditions stated in these terms and conditions. The granting of the Bonus Product does not affect the final price of the Main Product. The Bonus Product is not part of the purchase contract for the Main Product. In case of any defects of material or title of the Bonus Product, warranty claims of the Customer against Yamaha shall be excluded. Any claims of the Customer arising from fraudulent concealment, knowledge or grossly negligent ignorance of a material defect of the Bonus Product shall remain unaffected.

§ 7

Severability

Should any provisions of these terms and conditions be or become invalid in whole or in part, this shall not affect the validity of the remaining provisions.
